Medical Benefits

Coverage Year Limit	\$500,000
Coverage Year Deductible	\$0
Physician Office Visits	100% of the Allowable Amount
Inpatient Hospital Services	100% of the Allowable Amount
Hospital and Physician Outpatient Services	100% of the Allowable Amount
Emergency Hospital Services	100% of the Allowable Amount

Medical Benefit Limitations

Inpatient treatment of mental and nervous disorders including drug or alcohol abuse	100% of the Allowed Amount up to \$5,000 Maximum per Coverage Year for a maximum period of 30 days per Coverage Year
Outpatient treatment of mental and nervous disorders including drug or alcohol abuse	100% of the Allowed Amount up to \$1,000 Maximum per Coverage Year
Treatment of specified therapies, including acupuncture and physiotherapy	100% of the Allowed Amount up to a Maximum of 20 visits on an Outpatient basis
Repairs to sound, natural teeth required due to an injury	100% of the Allowed Amount up to \$500 Maximum per Coverage Year

Other Coverages

Emergency Medical Evacuation	100% of the Allowed Amount
Emergency Family Travel Arrangements	Maximum benefit up to \$3,000 for the cost of one economy round-trip air fare ticket to, and the hotel accommodations in, the place of the Hospital Confinement for one (1) person. 3 day wait period
Repatriation of Mortal Remains	100% of the Allowed Amount
Accidental Death & Dismemberment	Maximum Benefit: Principal Sum up to \$10,000 for Eligible Participant

Post Departure Trip Interruption

Transportation Benefit

Maximum Benefit up to \$1,500 per Coverage Year

Lodging & Incidentals Benefit

Maximum Benefit up to \$2,000 per Coverage Year and limited to \$200 per day for a Maximum of 10 calendar days

Emergency Medical and Travel Assistance services provided, including coordination of all evacuations and repatriations if needed

Pre-Existing Conditions

Covered same as any illness

Political Evacuation/Natural Disaster Coverage and Services provided through a separate agreement with Crisis24

Per Person/Per Event Limit: \$100,000 per person/per event subject to aggregate per event and annual limits
