

<b>Scholarship Theme:</b>	<p>Please create a Video Submission in response to the following:</p> <p>Show us the top 3 things you’re excited to experience while studying abroad! Create a short film! Record yourself reading a poem! Sing an original song! We want to see how creative you can get.</p> <p>NOTE: Your submission must be an original work created specifically in response to the scholarship theme. Unrelated or repurposed assignments/projects will not be considered.</p>
<b>Eligibility:</b>	All full-time students currently enrolled at a Post-Secondary US institution who will study abroad in Spring or Summer of.
<b>Exclusions:</b>	<p>The following are not eligible to participate:</p> <ul style="list-style-type: none"> <li>a. Students studying at educational institutions in the states of New York and Maryland;</li> <li>b. Students participating in non-credit bearing vacations, mission trips, service learning, or internships;</li> <li>c. Lewer employees (and members of their household) and immediate family members of Lewer employees (and members of immediate family members’ households).</li> </ul>
<b>Application Deadline:</b>	Monday, July 1, 2024 (Scholarship Winners will be announced August 15, 2024)
<b>Submission Examples:</b>	<p><b>Video submissions will have a 3-minute maximum time limit. Three winners will be selected.</b></p> <p><b>Examples:</b> Music video, commercial, short film, interpretive dance, etc.</p> <p>NOTE: <b>Must be original work. Any submission that includes copyrighted content (music, images, video, etc.) will be automatically disqualified.</b></p>

### Scholarship Application Instructions

1. Complete the included scholarship application (“Application”).
2. Create a video submission (“Submission”).
3. Email your Application and Submission to [scholarships@growyourgiving.org](mailto:scholarships@growyourgiving.org). Your submission must be either attached to the email, or the YouTube link copied and pasted in the body of the email.
4. All Submissions must be original content developed by the student applying for the scholarship. Any entry that utilizes third-party or stock footage must cite the source of said footage. (Please cite sources at the end of your video).
5. Please disclose if your submission utilizes Artificial Intelligence (AI) and include the prompts entered as well as the name of the AI platform.
6. Winners will be notified by August 15, 2024, and will be posted on the Lewerglobal [LinkedIn](#), [Facebook](#) & [Instagram](#) pages.
7. There is no fee for entering the contest; however, you are **responsible for any costs associated with your Submission, including postage.**
8. Applications may be verified to ensure compliance with all eligibility rules.
9. By checking the Affidavit and Liability/Publicity Release box on the attached Application, you confirm and legally attest you have read these rules as well as the ‘Your Journey Begins’ Contest Affidavit and Liability/Publicity Release found in this document.

7. I understand the winners’ school(s) will be notified in August 2024 and the scholarship funds will be sent or delivered directly to the school for delivery to the winner. Should I be selected as a winner, I understand I must be enrolled in and attending classes on a full-time basis at the school and must enroll and attend classes on a full-time basis the following summer or fall semester at the school. If I fail to properly enroll or attend classes, I will be considered ineligible and will be disqualified.
